The college encourages the teachers to participate in the Refresher Courses and Orientation Programs and various seminars and symposium to update themselves in different areas of research. To improve the teaching-learning process, teachers have full autonomy to purchase books, and journals for their respective departments through central library. Also, with facilities of smart board, visualizer, computers, internet connections, printer, scanner and photo copier, the teachers are assisted with the teaching-learning aids.
