Concept Note

“DHARMASĀSTRA: Contemporary Relevance & Interdisciplinary Perspectives” seeks to critically re-examine ancient Indian legal and ethical treatises not as static historical artifacts, but as dynamic frameworks capable of addressing modern global challenges. By bridging the gap between classical text and contemporary scholarship, this study explores how core concepts like *Vyavahāra* (judicial procedure), *Sādhāraṇa Dharma* (universal duties), and *Rta* (cosmic/ecological order) can inform current debates in jurisprudence, restorative justice, environmental ethics, and governance. Moving beyond traditional philology, the project utilizes an interdisciplinary approach—intersecting legal studies, sociology, and philosophy—to filter out contextual historical prejudices and extract sustainable, duty-centric models that complement modern rights-based paradigms, ultimately fostering a nuanced dialogue between ancient Indian wisdom and 21st-century societal needs.

Authors are invited to submit original, unpublished manuscripts for presentation.

 - Concepts of Wealth (Artha), Fair Taxation, and Ethical Economic Practices.
 - The Guru-Shishya Parampara and Moral-Value Systems in Light of Dharmasāstra.
 - Environmental Ethics, Sacred Landscapes, and Resource Management Systems.
 - Reflection of Dharmasāstra Principles in Medieval and Modern Bengali Works.
 - Post-Colonial Perspectives, Cross-Cultural Translations, and Comparative Ethics.
 - Ethics of Communication, Truth (Satya), and Public Discourse in the Classical Era.

- Moral Teachings and Folk Tales in Regional Stories and Devotional Songs (*Mangalkavya*).
- Duties of a Good Citizen and the Idea of Rights in Indian Tradition.
- Simple Stories, Fables, and Indian Moral Concepts Translated into English.
- The Role of Marriage, Family Values, and Respect for Elders in Traditional Society.
- The Importance of Speech (*Vak*), Sweet Words, and Avoiding Falsehood in Public Communication.
- Simple Living, Fair Trade Practices, and Honest Earning in Classical Texts.
- Quantifying the cosmos through the mathematical precision of ritual geometry, time-keeping (*Jyotiṣa*), and inheritance algorithms.
- Bridging *Dharmasāstra* and *Ayurveda* to address modern bioethics, public health protocols, and medical jurisprudence.
- Rooting modern corporate governance, fair trade, and ethical wealth accumulation in the principles of *Artha* and *Vārttā*.
