WHEREAS DUM DUM MOTIJHEEL RABINDRA MAHAVIDYALAYA, WEST BENGAL, INDIA and COLLEGE OF NATURAL SCIENCES, CAN THO UNIVERSITY, VIETNAM, recognizing the value of cooperation, have agreed to enter into this Linkage Agreement regarding knowledge exchange in economics and Commerce etc. The purpose of this non-binding linkage is to make possible and institute academic and Linkage for knowledge exchange specially in economics and commerce between DUM DUM MOTIJHEEL RABINDRA MAHAVIDYALAYA, WEST BENGAL, INDIA and COLLEGE OF NATURAL SCIENCES, CAN THO UNIVERSITY, VIETNAM, based upon the principles of mutual equality and the reciprocity of benefits.

NOW AGREEMENT WITNESSETH and it is agreed by and between both the Parties hereto as follows:

- 1. Each party will accept visiting members from the other party.
- 2. That the activity exchange programme will include exchanges in terms of knowledge especially in economics and commerce, and the exchange of research materials, publications, and information to facilitate academic and cultural interchange between the parties of this Linkage Agreement.
- 3. The number of members under the activities exchange programme will be as per the requirement of the activity, and shall be decided and settled prior to the programme between the signatories of this agreement.
- 4. The Agreement will stand valid for a period of Two years from the date of its execution. However, it shall be automatically renewed unless any party hereof communicates for its termination, with a prior written notification to the other Party, at least six months prior to the date of its expiry.
- 5. Both Parties will comply with the relevant laws in the jurisdiction in which it is situated. and that all the visiting members from either of the organizations shall comply with all relevant laws in the jurisdiction of the host party

- 2. Develop suitable training programs with both parties. To carry out any of these programs, detailed provisions of each program will be developed and agreed upon in writing by both parties.
- 3. This MOU shall impose no financial obligations on either party.
- 4. This MOU shall become effective on the date of signing by the representative of both parties and shall remain in effect for five (5) years. After that, the MOU will be automatically renewed for another 5 years unless either party provides written notice of termination at least six months before the termination date.
- 5. This MOU is made in two identical copies written in English. The parties will sign each document and retain an original copy.

Department of Mathematics, College of Natural Sciences, Can Tho University, Vietnam represented by its Head of the Department, Dr. Pham Bich Nhu, hereinafter referred to as the SECOND PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns). Both these organizations will be hereafter referred to as Parties.

II. Purpose of the Agreement

Both parties are interested in establishing a relationship that will promote cooperation and exchange in education and research. The parties agree as follows:

- Based upon the principle of respect for each other's independence and mutual benefits, the parties will carry out the following programs:
- (i) Facilitate student and faculty exchange programs;
- (ii) Conduct joint research projects;
- (iii) Organize collaborative workshops, seminars, and conferences;
- (iv) Develop and offer joint academic programs;
- (v) Share academic resources, such as libraries and research facilities through online and onsite mode if possible.
- 2. Develop suitable training programs with both parties. To carry out any of these programs, detailed provisions of each program will be developed and agreed upon in writing by both parties.

III. Term and Expiration of the Agreement

- This MOU shall become effective on the date of signing by the representative of both parties and shall remain in effect for five (5) years. After that, the MOU will be automatically renewed for another 5 years unless either party provides written notice of termination at least six months before the termination date.
- 2. This MOU shall impose no financial obligations on either party.
- This MOU is made in two identical copies written in English. The parties will sign each document and retain an original copy.

IV. NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

V. SPECIAL PROVISIONS

- Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
- All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
- The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.

VI. DISPUTES

If any dispute arises in respect of the MoU, in that case both the organisations will discuss and settle the matter amicably.



This document establishes the guiding terms and principles of collaboration between the two organizations:

I. Legal Frameworks of Both Organizations

This non-binding Memorandum of Understanding (MoU) is signed by and between

Swami Vivekananda University, promoted by "Regent Education and Research Foundation Trust" and conferred the status of a private university by the Government of West Bengal (West Bengal Act XV of 2019) and approved by the University Grants Commission (UGC) under Section 2 (f) of the UGC Act, 1956, has its campus at Telinipara, Barasat - Barrackpore Rd, Bara Kanthalia, West Bengal - 700121. It is represented by its Vice Chancellor, Prof. (Dr.) Subrata Kumar Dey from now on, is referred to as the FIRST PARTY.

Dum Dum Motijheel Rabindra Mahavidyalaya, having its college building at, 208/B/2, Dum Dum Road, Kolkata: 700074, West Bengal. Approved by the University Grants Commission under UGC Act 1956, Section 2(f) & 12(B) of the UGC Act, 1956 and NAAC accredited college with grade B, affiliated under the West Bengal State University and Government of West Bengal aided college represented by its Principal, Prof. (Dr.) Arijit Saha hereinafter referred to as the SECOND PARTY.



Both the Parties are pleased to agree to establish ties of academic cooperation to contribute to the achievement of their overall goals as institutions through the following, but not limited to:

- 1. Joint teaching and research projects.
- Collaboration in academic publications, research activities, field trips, etc.
- 3. Visits, training, and exchange of faculty, staff, and students.
- 4. Joint educational/vocational courses.
- Joint consultancy, PhD supervision, scientific publications.
- 6. Co-host and participate in conferences, seminars, symposiums, and workshops.
- Social and cultural programs.
- 8. Any other academic activity mutually agreed upon and beneficial to both.

III. Execution of the Agreement

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific sub-agreements, once approved by both parties, will be attached as annexes to this agreement.

The sub-agreements between both Parties will specify their objectives, conditions, ways of execution, financial support, the period the sub-agreement will be in effect, and administrative responsibility within each institution.

IV. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of five years. After these five years it will be automatically extended for same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and



expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the Parties. Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

NON-EXCLUSIVITY:

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

VI. SPECIAL PROVISIONS

- 1. On a case-by-case basis, Each party will get approval from the other party in writing before using the latter's name and logo for the activities hereunder.
- 2. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
- 3. The parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
- 4. Neither party can misuse this MoU by involving the name of the other without the written consent of the other party.
- 5. There will be no financial involvement by either of the parties.

VII. DISPUTES

If any dispute arises concerning the MoU, in that case, both organizations will discuss and settle the matter amicably.

- DDNBV will be responsible for the issue of Certificate to all successful students.
- DDNBV will provide Placement assistance to the successful candidates after completion 2. 3. of the Training Programs as per the available job openings.
- DDNBV will send copies of all printing materials/documents to DDMRM before mass 4. circulation.

TENURE

The MOU shall remain valid for a period of 3 years (three years) from the date of signing of MOU. The MOU can however be cancelled by mutual consent. However, in case of cancellation, both the parties will ensure successful completion of booked programs/mobilized batches etc.
